Subject:-Delegation of powers by State Transport Authority to Secretaries of RTA of respective regions posted as Regional Transport Officers.

Whereas it is considered necessary in public interest to delegate certain powers of State Transport Authority to Secretaries of RTA posted as Regional Transport Officers under sub-section (5) of section 68 of the Motor Vehicles Act 1988 read with rule 5.4 of Rajasthan Motor Vehicles Rules 1990 ;

It is, therefore, resolved in supersession of all previous resolutions in this regard, to delegate the following powers of the State Transport Authority to Secretaries of RTA posted as Regional Transport Officers for Jaipur (North), Jaipur (South), Jodhpur, Udaipur, Bikaner, Ajmer, Alwar, Kota, Sikar, Pali, Chittorgarh, Dausa and Bharatpur Regions :-

**(1) To decide matters pertaining to :-**

- (i) Tourist permits for motor cabs, maxi cabs, onni buses having seating capacity above 13 in all and sleeper coaches (Camper vans) under sub-section (9) of section 88 of the Act.
- (ii) Transfer of permit under section 82 of the Act for which he is the granting Authority under delegation.
- (iii) Replacement of one vehicle covered by a permit (Other than temporary permit) for which he is the granting authority under delegation by another vehicle (not covered by any permit) of prescribed model and of same nature under section 83 of the Act and subject to the condition that the vehicle is readily available with him and also in his name. For the purpose of replacement of vehicle the prescribed model shall mean the model prescribed for grant of permit.

- (iv) To issue notice and to decide matter (other than the power to cancel a permit) under section 86 of the holder of a permit for which he is permit granting authority under delegation.
- (v) To cancel or refuse to cancel a permit for which he is a permit granting authority on an application made by the permit holder under rule 5.35 of Rajasthan Motor Vehicles Rules 1990.

While exercising above delegated powers:-

- (i) Secretary shall ensure that at least at the time of issue of permit or making any endorsement on a permit issued by him the vehicle is registered in the name of the applicant unless relaxation is granted by the State Transport Authority.
- (ii) Secretary shall ensure the compliance of all directions given by the State Transport Authority to from time to time and of all provisions of Motor Vehicles Act and Rules made there under.
- (iii) Secretary shall do all ministerial Acts on behalf of the State Transport Authority.





Subject:-Delegation of powers by State Transport Authority to Secretaries of RTA of respective regions posted as Regional Transport Officers and to officers of Transport Department.

Vide STA resolution no. 1/2013 dated .... 02-2013 STA had delegated it's certain powers to Secretaries of RTA of respective regions posted as Regional Transport Officers. In this resolution, power of issuing notice and to decide matter (other then the power to cancel a permit) under Section 86 to holder of a permit had already been delegated for which Secretaries of RTA are permit granting authority.

In public interest in is herby resolved to delegate the following powers of STA to officers of the Transport Department not below the rank of Motor Vehicle Sub Inspector to compound the cases of breach or infringements of the following provisions of the Act under sub-section (5) of the section 86 of Motor Vehicle Act, 1988 at a sum of money mentioned below :-

(A) Using vehicles in contravention of condition of permit

Mentioned in section 192 (A) of the Motor Vehicle Act, 1988


